Decision No. (120/2012)

Determining the Fees of Accreditation of the Registrar and the Registration Fees of Domain Names under the country code Top-Level Domain (.om) and the Arabic IDN (ع.م.ن.)

Pursuant to the Telecommunications Regulatory Act issued by Royal Decree No. 30/2002;

The Executive Regulation of the Telecommunications Regulatory Act issued by Decision No. 144/2008;

The Domain Names Regulation issued by Decision No. 119/2012;

The Authority's Board of Directors approval on 13/8/2012 in its meeting No. 19/2012 .

Based on the exigencies of the public interest;

It is decided

Article 1:	The annexed provisions shall have effect in relation to the fees of application for the accreditation of the Registrar and its renewal, and the fees of registration of domain names and its renewal under the two top levels (ع.م.ن.) and (.om).
Article 2:	The Accredited Registrar shall collect the fees stated in table (B) of the attached appendix and send the same to the Authority.
Article 3:	The provisions of this Decision do not breach any international agreements to which the Sultanate is a party.
Article 4:	This Decision shall be published in the Gazette and shall become operative from the date following its publication.

Application fees for accrediting the Registrar and its renewal

Serial No.	Item	Fees in Omani Riyal
1	Application for accrediting the Registrar of Omani private companies and institutions.	Two hundred Omani Riyal Non-refundable
2	Application for accrediting the Registrar of non-Omani private companies and institutions.	Four hundred Omani Riyal Non-refundable
3	Accreditation of Registrar	Five hundred Omani Riyal
4	Annual Accreditation Renewal	Five hundred Omani Riyal

The Accredited Registrar undertakes to deposit an amount of Two Thousand (2000) Omani Riyal in the treasury of the Authority as a deposit to ensure fulfilling any obligations stipulated in the Domain Names Regulation and the Registrar-Registrant Agreement, and shall be refunded upon the expiry of the accreditation. However, the Authority may deduct all its financial dues from that deposit if there are any dues left to be paid by the Registrar to the Authority, and refund the remaining if any.
